Opportunity Place Drop-In Center/Street Outreach: A-SPAN's services
start with street outreach, as staff seek out homeless people living on
the streets. Staff distribute items such as blankets and encourage
people to visit Opportunity Place (OP). At OP, clients can take a
shower, do their laundry, and engage in case management for help with
applying for benefits or a job, or getting referrals for mental health
and substance abuse treatments or medical care.

Permanent Supportive Housing Program: The Permanent Supportive Housing
(PSH) Program provides housing and case management for people who were
chronically homeless prior to placement, and who suffer from mental
illness and/or substance abuse. PSH clients receive help with such
things as transportation, budgeting and money management and activities
of daily living.

Emergency Winter Shelter: The Emergency Winter Shelter is open nightly
from November 1 through March 31. The 73-bed shelter with overflow
capacity of 88 provides sleeping arrangements, breakfast and dinner,
housing case management, mental health counseling, employment
counseling and onsite medical care.
