1 Briefly describe the organization's mission: Arlington Street People's Assistance Network (A-SPAN) provides life-sustaining services for Arlington's homeless. Our mission is to provide permanent housing for this vulnerable population through outreach, support and relationships built on trust and respect.

4a (Code:) (Expenses \$ 1,958,187. including grants of \$) (Revenue \$) Permanent Supportive Housing Program: The Permanent Supportive Housing (PSH) Program provides housing and case management for people who were chronically homeless prior to placement, and who have a disabling condition. PSH clients receive help with such things as transportation, budgeting and money management and activities of daily living.

4b (Code:) (Expenses \$ 1,456,597. including grants of \$) (Revenue \$ 1,513,648.) Homeless Services Center- Shelter Program: The Shelter Program at the Homeless Services Center offers sleeping arrangements for over 50 people per night, provides three meals daily, showers, laundry facilities, and access to case managers and medical services. A-SPAN's shelter services are now available year-round, both during the hypothermia season and throughout the year. This provides continuity of service, and helps our clients achieve a higher level of stability and wellness. It will lead to more people in need getting into housing. See Schedule O for additional information.

4c (Code:) (Expenses \$ 456,390. including grants of \$) (Revenue \$) Homeless Services Center- Day Program: The Day Program at the Homeless Services Center is the hub of operations at A-SPAN where clients have access to a wide range of wraparound services. A-SPAN is unique in that our services are low barrier, as clients are not required to produce identification, sign a service agreement or engage in case management to access them. A-SPAN's services start with street outreach, as staff seek out homeless people living on the streets. Staff distribute items such as blankets and encourage people to visit Opportunity Place at the Homeless Services Center. See Schedule O for additional information.

Case managers link shelter guests to alternative year round emergency shelters as well as transitional and permanent housing programs. They assist guests with dental and medical referrals. A-SPAN's Employment Coordinator assists individuals seeking stable employment. Mental health and substance abuse therapists are available through our partnership with Arlington County's Treatment on Wheels program.

A-SPAN is working to end homelessness in Arlington by providing shelter, basic hygiene and health needs and, most importantly, moving people into homes.
